

NOTICE OF MEETING OF THE COMMISSIONERS COURT OF BANDERA COUNTY, TEXAS


Notice is hereby given that a **REGULAR MEETING** of the above-named Commissioners Court will be held on the **12th** day of **FEBRUARY 2026 at 10:00 A.M.**, in the County Courthouse, 500 Main Street, **Bandera, Texas**, at which time the following subjects will be discussed, to wit;

01.) Public Forum.

The following items will be discussed, reviewed and considered for possible action:


- 02.) Spring Creek Ranch Subdivision, Lots 213 and 214 – request to replat into single Lot: (Pct. #2)
  - a.) Consider Final Plat.
- 03.) Bellows Addition Subdivision – request to replat remaining portions of Lot 10: (Pct. #3)
  - a.) Consider Preliminary Plat.
- 04.) Joshua D. Teitge, Sheriff - request permission to apply for grants:
  - a.) For Rifle Resistant Body Armor through The Office of Governor, State of Texas, the Public Safety Office; and request approval of a Resolution; and authorize Commissioners Court to sign.
  - b.) For purchase of Patrol Deputy Body Armor from Peterson Foundation Grant.
- 05.) Consider credit card processing services for Tax Office; select and enter into a contract agreement with a credit card company.
- 06.) Consider Order adopting County-wide Burn Ban.
- 07.) Review and affirm the County’s Investment Policy and Strategies; pursuant to Texas Local Government Code, Section 2256.005 (e).
